## September 14th - Arrival in Málaga - Transfer to Sotogrande

## September 15th - Golf at Real Club Valderrama (or similar)



Today is the highlight of the trip: a round at the world-famous **Real Club Valderrama**, consistently ranked as the best course in continental Europe. Known for hosting the 1997 Ryder Cup, Valderrama's immaculate fairways and demanding layout make it a true bucket-list experience. After the round, enjoy a celebratory evening with leisure time at the hotel.

# September 16th - Golf at La Reserva Club (or similar)

Your second round takes place at **La Reserva Club**, a modern masterpiece nestled in the Sotogrande hills. With wide fairways, sweeping sea views, and a reputation as one of Europe's Top 100 courses, it's a rewarding challenge for all levels. After golf, perhaps enjoy tapas at Sotogrande Marina or take an optional excursion to the medieval fortress town of Castellar de la Frontera.



## September 17th - Golf at Finca Cortesín (or similar)



Travel to **Finca Cortesín**, home of the 2023 Solheim Cup, and experience one of Spain's finest golf resorts. The course offers rolling terrain, pristine conditioning, and spectacular vistas of the Mediterranean.

# September 18th - Golf at Hacienda Links (or similar)

Play a round at **Hacienda Links**, one of Spain's rare true links-style courses, with fairways running along the Mediterranean coastline and panoramic views over the Rock of Gibraltar. After golf, you may opt to visit Gibraltar itself or relax with a walk on the nearby beaches. Dinner this evening will showcase Andalusian cuisine in a relaxed setting.



## **September 19th - Leisure or Optional Excursion**

Your final full day is left at leisure. You may relax at the SO/ Sotogrande's luxurious spa and wellness facilities, or add an optional round at another top course such as San Roque Old Course or Villa Padierna.
